**Supreme Court Rules New York Prosecutors Can Access Trump's Tax Records for Criminal Investigation** (the U.S. Supreme Court issued a landmark decision reaffirming the centuries-old principle that “no citizen, not even the President, is categorically above the common duty to produce evidence when called upon in a criminal proceeding.”)



**Groups Seek Remedy for New York's Highest-in-the-Nation Rate of Ballot Rejection** (Selendy & Gay and Campaign Legal Center represent a coalition of groups that filed a lawsuit urging a federal court to change New York State's flawed absentee ballot verification requirements in time for the 2020 General Election.)



**Selendy & Gay Announces Associate Bonuses** (After a remarkable year, Selendy & Gay announced associate bonuses, significantly topping the established law firm scale.)



**How Law Firms Can Fight Racism in Their Hiring** (Most major law firms have some sort of diversity initiative. Too often, they pay lip service to the idea without making the real systemic changes necessary to make a difference.)



**Public Service Workers Reach Significant Class Action Settlement with Loan Servicer Navient** (Members of the American Federation of Teachers union have agreed to settle a proposed nationwide class action lawsuit with Navient Solutions, one of the nation's largest student loan servicers.)



**U.S. Appeals Court Issues Landmark Ruling Recognizing Federal Right of Access to Literacy** (The U.S. Court of Appeals for the Sixth Circuit issued a landmark decision recognizing a fundamental federal right to a basic minimum education and access to literacy.)



**Wave Of Suits Could Lead To New Era In Crypto Litigation** (A flood of securities class action complaints filed in New York federal court against a host of digital asset exchanges and issuers may foreshadow a new phase in fintech litigation, building on a flurry of targeted actions and guidance over the past year.)
