Temidayo Aganga-Williams is an experienced litigator and former federal prosecutor who represents clients facing complex government enforcement actions, internal investigations, and congressional oversight. Temidayo also represents plaintiffs and defendants in high-stakes commercial disputes involving complex contractual matters, business torts, and bankruptcy.

Prior to joining Selendy Gay, Temidayo served as Senior Investigative Counsel for the House Select Committee to Investigate the January 6th Attack on the U.S. Capitol. Before that, he was an Assistant U.S. Attorney in the Criminal Division of the U.S. Attorney's Office for the Eastern District of New York.

As Senior Investigative Counsel, Temidayo was responsible for investigating the facts, circumstances, and causes of the attack and issues relating to the peaceful transfer of power. In that role, he conducted depositions and interviews of dozens of witnesses, including senior advisors to President Trump, provided legal and strategic guidance on novel congressional investigation issues, coordinated the presentation of evidence for nationally televised hearings, and contributed to the Select Committee's final report.

As an Assistant U.S. Attorney in Brooklyn, Temidayo investigated, prosecuted, and tried complex and sensitive cases across a wide spectrum of subject matters. He was a member of the Business and Securities Fraud section, in which he investigated and prosecuted white collar cases, including bank fraud, tax fraud, mail and wire fraud, and Bank Secrecy Act violations. He was also a member of the International Narcotics and Money Laundering section, in which he investigated and prosecuted money laundering and narcotics trafficking organizations, organized criminal conduct, and racketeering operations throughout the United States and internationally.

Temidayo has briefed and argued numerous cases before the U.S. Court of Appeals for the Second Circuit. He received the U.S. Department of Justice's Assistant Attorney General's Award for Distinguished Service for his extraordinary contributions. He also received the U.S. Department of Homeland Security, Homeland Security Investigations' Investigative Group of the Year Award.

Temidayo was recognized as a "Notable LGBTQIA+ Leader" by *Crain's New York Business* and as one of the "500 Leading Lawyers in America" by *Lawdragon*. Temidayo was also named to *Benchmark Litigation's* "40 & Under" list, which recognizes the nation's most notable up-and-coming litigators, and to the *New York Law Journal's* "Rising Stars" list, which recognizes the most promising and accomplished lawyers 40 and younger.

His insights on the latest legal developments are regularly sought out by prominent media outlets, including CNN, MSNBC, NBC News, BBC News, *The Washington Post*, *The Wall Street Journal, Financial Times*, *Politico*, and *Law360*.

- Numerous individuals and entities in financial fraud investigations conducted by the DOJ, SEC, and other governmental agencies.
- Former CEO of a multinational technology company in connection with a securities and accounting fraud investigation by the DOJ and SEC.
- Former executive of a multinational company in connection with a Foreign Corrupt Practices Act investigation by the DOJ and the SEC.
- Citigroup in connection with investigations involving financial benchmarks, including LIBOR and foreign exchange trading (FX), conducted by the DOJ, the SEC, the CFTC, and other regulators around the world.

- The Official Committee of Unsecured Creditors in the Chapter 11 case of Celsius Network LLC in the U.S. Bankruptcy Court for the Southern District of New York, acting as the fiduciary for 1.7 million account users that used the Celsius platform before its bankruptcy filing.
- The U.S. estate of Nortel, a multinational telecommunications and data networking equipment manufacturer, in an unprecedented seven-week, cross-border trial (conducted simultaneously in Ontario and Delaware) concerning the allocation of \$7.5 billion from the global liquidation of the assets of the Nortel Networks group of companies.

Public Interest Work

Temidayo maintains an active public interest practice, including a focus on furthering pro-democracy efforts. He has authored numerous amicus briefs, including an amicus brief before the U.S. Supreme Court in *Trump v. United States*, which argued against immunity from criminal prosecution for President Trump. Temidayo has spoken on these topics at numerous institutions, including Columbia University, Furman University, and the National Press Club (the world's leading professional organization for journalists).
