### **Representative Matters:**

- Cerberus Capital Management, L.P: Represented private equity firm Cerberus Capital
  Management as plaintiff in a breach of contract action against the Canadian Imperial Bank of
  Commerce, one of Canada's largest banks. In 2018, the First Department agreed with Cerberus'
  interpretation of the agreements and held that CIBC's contrary interpretation was "unmoored"
  from the contracts. After a damages hearing and related decision that rejected nearly all of
  CIBC's damages arguments, the New York Supreme Court on February 6, 2023 entered
  judgment for Cerberus for \$855 million.
- MASTR Adjustable-Rate Mortgages Trust 2006-OA2 et al: Successfully represented plaintiff trustee against UBS in breach-of-warranty suit regarding three residential mortgage-backed securities (RMBS) trusts.
- Markel CATCo: Represented retrocessional reinsurer of catastrophe events in a \$300 million suit
  in the Delaware Court of Chancery against D.E. Shaw, an insurance-linked security investor,
  which sought to unilaterally change the terms of its contract. The investor ultimately abandoned
  its effort to change the contract.
- Trilantic Capital Partners IV: Represented a private equity company in a declaratory judgment action challenging the UFCW Int'l Union Ind. Pension Fund's assertions of ERISA withdrawal liability against a private equity investor.
- Altaba (formerly Yahoo Inc.): Represented Altaba against BNY Mellon Trust in Delaware Court of Chancery, obtaining dismissal at the pleading stage of a claim that our client owed \$300 million under a \$1.4 billion convertible note agreement after the sale of Yahoo's operating business to Verizon.

Will earned his J.D. from the UC Berkeley School of Law and served as a law clerk to Justice Daniel Winfree of the Alaska Supreme Court. He was a Captain and Signals Intelligence Officer in the United States Marine Corps, producing intelligence assessments in support of combat operations in Helmand Province, Afghanistan, and supporting relief efforts following the 2011 Tohoku earthquake and tsunami in Japan.
